3. A vacancy will exist at the end of your term. A new application must be submitted for reappointments and new appointments.
4. It is the recommendation of the County Commissioners that board members serve only 2 consecutive terms on any one board.
5. Serve in such a way as to represent all of the residents of Crook County.
6. Upon receipt of a letter from a board that a member has missed 3 consecutive meetings in any 12 month period, the Crook County Commissioners will declare a vacancy and advertise for a new board member.
7. I understand that I may also be removed for any criminal charge or for cause by the Board of County Commissioners.
8. I authorize the Board of County Commissioners to do a background search and Criminal History before or after I am appointed.
