The Applicant and the County agree as follows:

1. The Applicant shall pay the Crook County Clerk in advance for the cattleguard at the following rates:

- \$2,500.00 for a sixteen foot (16') cattleguard with cement footer
- \$3,250.00 for a twenty-four foot (24') cattleguard with cement footer

The funds shall be deposited in an escrow account until the cattleguard is installed.

2. The BOARD agrees to install said cattleguard and shall provide the labor, included in the rates in No. 1 above, and the equipment to install the cattleguard at BOARD'S discretion.

3. The length of the cattleguard used will not be less than sixteen feet (16') nor more than twenty-four feet (24') as determined by the BOARD.

4. After installation, said cattleguard shall be maintained, extended and replaced by the BOARD at the BOARD'S sole discretion until such time as the County Road is vacated according to law whereupon the cattleguard shall revert to the Applicant, his heirs or assigns who then own the adjoining real property.
