The regular meeting of the Crook County Land Use Planning & Zoning Commission was called to order July 15, 2013 at 7:01 p.m. by Chairman, Nels J. Smith.

**Amend the Agenda**

Chairman, Nels J. Smith asked that the agenda be amended by adding a discussion item about Jurisdiction and Prescribed Fire at Devils Tower National Monument under New Business; the agenda was amended by unanimous consent.
