GENERAL ELECTION TUESDAY, NOVEMBER 2, 2010

The polls are open from 7 A.M. through 7 P.M. If you are NOT already registered to vote, you may register and vote AT YOUR POLLING PLACE ON ELECTION DAY. You will need to show an acceptable form of ID before registering. If you will be gone on General Election Day, and you are registered you may vote absentee. If you wish to do this, please contact the Crook County Clerk's Office, PO Box 37, 309 Cleveland, Sundance, Wyoming, 82729, phone 307-283-1323. If you are not registered, you may register at the Crook County Clerk's Office and vote absentee, (you will need to show an acceptable form of ID). If you need to change your political party, address, or name, you may do this at your polling place the day of the Election.

If you require assistance to vote by reason of blindness, disability or inability to read or write, you may be given assistance by a person of your choice. If you have questions regarding the accessibility of your polling place, please contact your County Clerk. Absentee ballots will be available to you.
